General guidelines for filling RAP application form:

1. Foreign visitors are requested to fill complete form in order to facilitate them with Restricted Area Permit. Incomplete form will not be entertained.
2. Separate forms are required to be filled for each individual.
3. The soft copy of the filled form can be sent to email id: immigration.and@gov.in at least one day prior to arrival to save their time during arrival at Port Blair.
4. Visitors are requested to report at immigration counter at Airport/Seaport, Port Blair and personally affix their signature on the RAP form at the time of arrival/reporting at Immigration Counter for issuance of Restricted Area Permit.
5. Visitors can also carry the hard copies filled RAP Form during their arrival at Port Blair and can obtain Restricted Area Permit.
6. RAP Forms can also be obtained free of cost at Airport/Seaport during arrival at Port Blair.
7. Visitors are advised to carry all original travel documents viz. Passport, Visa & other necessary clearances.
8. Foreign diplomats and members of the United Nations and International Organizations holding Diplomatic /Official Passport are required to obtain prior approval from Ministry of External Affairs.
9. Citizens of Afghanistan, China and Pakistan and foreign nationals of Pakistani are required to obtain prior approval of the Ministry of Home Affairs.
10. Foreign journalist, TV camera person etc, including foreign journalist already based in India (having Visa Type J), who desire to visit Andaman Nicobar Islands are advised to apply through Ministry of External Affairs (External Publicity Division) of special permit giving full particulars, inter alia, of the purpose and the date of proposed visit.
